Identification: A valid passport book with a minimum of six months of validity beyond completion of travel is required. The passenger names listed on each reservation must match the names on each passenger's passport. Passengers without proper identification and documentation will be denied boarding without refund. Please contact your Travel Consultant if you have any questions on documentation. If you are not a U.S. Citizen, please contact us immediately.

United Kingdom Electronic Travel Authorization: Starting January 8, 2025, U.S. citizens traveling to the United Kingdom for short visits, tourism, or business, will need an Electronic Travel Authorization (ETA) if they do not have a UK visa or legal residency in the UK or the Republic of Ireland. This requirement applies to all parts of the UK, including Northern Ireland. The ETA is similar to the U.S. ESTA system and acts as a pre-clearance for travel. This change is part of the UK's move towards a digital border system.

Cancellation Penalties: Cancellation penalties up to 100% of trip cost may apply based on supplier cancellation policies.
