Visit the Flight 93 National Memorial, located at the crash site of United Airlines Flight 93, which was hijacked during the September 11, 2001 attacks. The memorial was designed to honor the passengers and crew, who bravely stopped the terrorists from reaching their intended target. At the Visitor's Center, explore exhibits which pay tribute to the heroes, and detail the events of September 11th. Included in the tour is the Memorial Plaza, where the Wall of Names commemorates the 40 heroes of Flight 93. Listen to the 93-foot Tower of Voices, which houses 40 wind chimes, one for each passenger and crew member who died in the crash. Also, a trip to the Flight 93 Memorial Chapel.
