## Double Occupancy: \$10,495 per person

\*Rates are per person, based on double occupancy. Single Occupancy, third & fourth person rates are available upon request and are based on availability at the time of booking. **PAYMENT:** A **non-refundable deposit of \$350.00 per person** is due at time of booking to hold your reservation. All bookings must be confirmed and deposited on or before **September 23, 2022**. Final payment is due to AAA Travel no later than **December 8, 2022**. Payments are accepted in the form of cash, check (made payable to AAA Reading-Berks), or most major credit cards.
